Appendix 2. Confirmation of Recordation of Public Access Easements

Recordation of Easements

The City has been tracking the recordation of easements for scenic, historical, and public access purposes. A list of recent transactions were researched as a part of the development of the *City of Alexandria Open Space Master Plan 2017 Update Implementation Strategy*. Court records were searched to confirm that public access and scenic easements, proposed during the development process, were recorded in the land records. Beginning with a table provided by the City of Alexandria's Park and Planning staff, each entry was researched and where recorded, copies were made of the plats and that information was transferred to the City's GIS mapping system and incorporated into the updated acreage figure of protected open space in the City if it was not already mapped in the system.

Working through the 2015 year, the list of approved public access easements was verified through a search of court records. Where possible, a plat was pulled and that information was transferred to the GIS data set. This is a challenging task, as project names and addresses often change mid-stream during the development process. Most of the subject properties were successfully verified. In the future, this document includes a recommended action to streamline this process, better assuring formal notification once the property owner or their representative has formally recorded the easement.

The original table has been rearranged to indicate those properties that have documentation that the easements were recorded and those properties that require further research. Some of the properties were more challenging than others to confirm. Names changed from project inception to project completion on four of the projects. Other projects were classified under the category of public access easement, but when the deed was reviewed the term was scenic easement and no public access was granted. Another property, although originally included on the public easement recordation list, was actually a historic easement. Still others were untraceable and are noted as requiring additional research.

An attempt was made to research development projects in the approval pipeline in 2016 by reviewing a list of DSUP properties. Although a number of pertinent plans were pulled, there currently is no easy or clear method to track their progress and their provision of open space during the approval process. Information related to open space is not consistently entered on the same plan sheet, meaning that the researcher must plow through hundreds of pages of construction documents in the hope of finding a reference to public open space. Sometimes included on the landscape sheet, other times referred to on the site plan, future work should include a method to track the proposed commitments within the DSUP plan approval process.

Recommendation for Moving Forward

A line should be added to the current development checklist that requires the developer to provide the City with a certified document attesting that the recordation has been filed in the land records as is currently required for stormwater easements prior to the City releasing/approving the site plan. This is included in the list of Actions under Recommendations.

Public Access Easements

Documentation Complete

Four of the properties requiring confirmation of recordation were successfully documented through records research and mapped in the GIS layer, as noted below. Acreage measurements vary between data sources. Information provided in the 2014 Typology Table and as measured from GIS data often differ. For purposes of this Update, the GIS figures were used for consistencies sake, as all properties do not have survey data. If information uncovered suggested that the property be recategorized, the header for each sub-section of the table indicates such.

Documentation Complete, continued

Two properties listed on the Public Access Recordation are not public access easements. 1500 King Street is more appropriately included in the Historic Easements listing. The plats for 1500 King Street do NOT display easements. INOVA Alexandria’s plats note a Scenic Easement but not a Public Access Easement. Access is limited to City staff for maintenance purposes if permission is granted in advance, per the language included in the deed.
