3. STAFF REPORTS AND UPDATES

TAXICAB HEARING:

4. **ISSUE:** Hearing in consideration of a recommendation to place a certificate of public convenience and necessity to operate a taxicab company in the City of Alexandria on probationary status for failure to provide the minimum level of dispatch service required by City Code Section 9-12-33(c).

BOARD ACTION: Mr. Lonnie Rich and Joyce Woodson spoke on the behalf of Union Taxicab Cooperative. Mr. Cota made a motion, seconded by Mr. Sergeant, to defer action for one month to allow Union Taxicab Cooperative additional time to form and approve a new business plan and to submit this plan to Staff by March 13, 2009, The Board voted unanimously to approve the request.

PUBLIC HEARINGS:

5. **ISSUE:** Consideration of a request to install NO PARKING BETWEEN SIGNS restrictions at the Centennial Row Condominium driveway

entrance on the east side of the 200 block of South Payne Street.
