Northern Virginia Transportation Authority (NVTA)	Nine cities/counties in NoVa with a 16-member board. Northern Virginia Transportation Commission (NVTC)	Manages and controls the functions, affairs, and property of the Northern Virginia Transportation District which is comprised of six member jurisdictions, including Alexandria. NVTC provides a policy forum for its region and allocates state, regional, and federal transit assistance.	7-Oct	4-Nov	The NVTC Board in its October meeting passed a resolution calling the funding and provision of public transit services in Northern Virginia to be its primary focus with a provision that local representation in some form should remain at the WMATA Board	To be determined.
