City Council	City Council approves the annual Capital Improvement Program for the City of Alexandria.	27-Nov	11-Dec	At the City Council meeting of November 13, 2012, Council approved an application for VDOT revenue sharing funds to rehabilitate Eisenhower Avenue from S. Van Dorn Street to Clermont Avenue. At the November 27, 2012 legislative meeting, City Council considered several transportation measures in the legislative package, including: supporting a letter from Virginia Crescent jurisdictions endorsing additional transportation funds, providing funds for the NVTA, providing funds for the Potomac Yard Metro, and opposing measures proposed in SJR297 to base State transportation funding on performance indicators. Commonwealth Transportation Board (CTB)	Virginia Dept. of Transportation, Dept. of Rail & Public Transportation, Dept. of Aviation, Port of Virginia. Board sets transportation policy and funding priorities for Virginia.	5-Nov	5-Dec	On November 5, 2012, the CTB received a briefing on the 2035 update of the Virginia Surface Transportation Plan. They discussed investment priorities and performance-based planning. City staff has been involved in the development of the Statewide Transit and TDM Plan which is providing project and investment information that will be included in the final 2035 Plan.	None
Transportation Planning Board (TPB)	Metropolitan Washington Council of Governments. The regional planning body that serves as the federally designated Metropolitan Planning Organization.	28-Nov	19-Dec	TPB discussed the CLRP and two federal transportation programs revised by MAP-21: the Transportation Alternatives Program and the revised Section 5310 program.	None
Northern Virginia Transportation Authority (NVTA)	Nine cities/counties in NoVa with a 16-member board. Charged with preparing and implementing a regional transportation plan.	12-Nov	24-Jan	NVTA approved the Transportation Efficiency and Consolidation study, as well as the FY 2014 – FY 2019 RSTP and CMAQ program for northern Virginia. The City received the full CMAQ and RSTP funding amounts that it requested.	None
Northern Virginia Transportation Commission (NVTC)	Manages and controls the functions, affairs, and property of the Northern Virginia Transportation District which is comprised of six member jurisdictions, including Alexandria. NVTC provides a policy forum for its region and allocates state, regional, and federal transit assistance.	1-Nov	6-Dec	NVTC received a briefing on the Transportation Efficiency and Consolidation Task Force and approved the final report. Washington Metropolitan Transit Authority (WMATA) Board	Provides rail, bus and paratransit services regionally and determines agency policy and provides oversight for the funding, operation, and expansion of transit facilities.	15-Nov	20-Dec	The WMATA Board approved for the release of a report which reviewed WMATA Board member actions in a real estate transaction.
