Re: Community Concerns with Noise Walls Evaluation Process Related to VDOT Project I-395 HOV Ramp at Seminary Road with Auxiliary Lane Extension

Dear Senator Ebbin:

On behalf of the Alexandria City Council, I would like to bring to your attention resident concerns brought to our November 16, 2013 public hearing regarding the Virginia Department of Transportation (VDOT) project sound walls as proposed along I-395.

As part of this project, VDOT commissioned a noise impact analysis, the final report of which was issued on November 18, 2013. In this study, five noise walls were evaluated and determined to be feasible and reasonable in accordance with VDOT State Noise Abatement Policy.

Several residents (some of whom are within the impacted area as defined by federal/state guidelines) expressed concerns about the real benefits of these noise walls and would like to have sufficient time to evaluate this noise impact analysis before voting on them. Another concern raised by the community is the loss of trees and the visual impacts associated with this proposed work.

Since the issue is largely under State jurisdiction, the City would appreciate your making the following recommendations to VDOT:

- It should carry out an expansive outreach program to the widest audience as practically possible.
- It should extend the voting deadline (even beyond the current VDOT voting deadline of January 2, 2014) to allow residents sufficient time to evaluate the noise impact analysis report and understand the prescribed voting procedure.
- It should, as much as possible, minimize the loss of trees and visual impacts to the communities by enhancing the tree canopy along the I-395 construction project.
