SUBJECT: BUDGET MEMO #8 : TEN YEAR HISTORY OF REAL PROPERTY TAX INCREASES AND DECREASES

This memo responds to Councilmembers Smedberg and Krupicka's request for a review of the net tax increase paid by Alexandria residents over the last ten years, broken down by property type.

The following two charts presents the increase or decrease by property type for the past ten years. Tax year 2004 reflects the equalized assessed value information. Tax years 1995 to 2003 reflect the land book information of each year.
